## **Towns County begins March to Macon for a state title**

Lady Indians (26-1) capture Region 8-A crown on the road with victories over Athens Academy, Hebron and Prince Avenue Christian

The Towns County Lady Indians begin their March to Macon after sewing up a Region 8-A Championship with a 55-47 victory over Prince Avenue Christian on Saturday night.

Gabby Arencibia, Jordan Moss and Ali Bleckley combined for 38 of the Lady Indians' final tally of 55 points.

The Lady Indians used six 3-point baskets by three different players between the 2:15 mark of the first quarter and the 3:20 mark of the second to great advantage in racing out to what proved to be an insurmountable 33-15 lead by exactly the 2 minute mark of the second quarter.

Scoring leaders for the game were Arencibia with 15 points, Moss with 12, Bleckley

with 11, Eryn Cochran with 6, Dadrian Blythe with 5, Lindsay Patton with 4 and Makayla Underwood with 2 points. Arencibia also led in assists with 5 and was followed by Bleckley and Cochran with 3 each and Underwood with 2.

The next opponent for the Lady Indians arrives Friday evening in the form of the Mt. Zion Lady Eagles out of Region 6-A, Sub Region B.

"Our Lady Indians will be hosting Mt. Zion in the first round of the state basketball tournament this Friday, Feb. 25th, at 7 p.m.," said TCHS Principal Roy Perren. "The state requires us to charge \$7 admission to the tournament games and we are allowed to recognize only GHSA issued passes (and press passes) for admittance to the game. "Mt. Zion is the No. 3

## project funding slated for 2014

#### Proposed widening project's estimated cost at \$32.3 million

An 8.3-mile proposed widening project from Blairsville to Young Harris is estimated to cost \$32.3 million, according to Georgia Department of Transportation Project Manager Steve Adewale.

The GA 515/US 76 APD-0056project, 02(209), Union and Towns Counties, P.I. No. 122900, is in the conceptual phase of development, and was scheduled to be discussed with stakeholders on Tuesaccording to Adewale.

Young Harris Mayor Andrea Gibby said that patience is necessary as both the city and its residents wait for a conceptual project design from GDOT.

She said that the city doesn't know enough about the project to pass judgment of whether it's good for the city or not. It's one of those occasions where everyone will have to wait and see what happens next. She encouraged residents to become informed about the project.

## **GHSA could change the** face of Class A athletics

Public and private school titles proposed

The great divide between public and private schools competing for state championships is expected to be a hot button of conversation at the Georgia High School Association's Executive Committee Meeting in March.

A proposal has been submitted that if accepted by GHSA, would allow Class A public and private schools to compete in the regular season, but divide the two come tournament time beginning in 2012.

The GHSA Reclassification Committee met in October to discuss innovative plans to resolve some of the perceived problems with the existing classification structure of GHSA schools.

The Reclassification Committee is currently investigating several plans, and it is hoped that one plan will be presented at the March meeting of the Executive Committee for approval, according to the GHSA Web site.

According to GHSA Executive Director Ralph Swearngin, this could merely be a tweaking of the existing structure, or it could be a revolutionary plan to change the number of classifications and/or the number of state championships.

'Many of the complaints with the existing re-

gion structures will be difficult to fix, and some of the complaints are actually contradictory," according to Swearngin. "For example: in Class AAAAA, there are concerns that the gap between 1,900 students and 3,500 students is too big; but others are concerned because there are not as many teams in AAAAA as there are in AAAA.

'Obviously, those two opinions contradict each other," he said on the GHSA Web site.

Swearngin also touched on the public school/private school debate.

"It is no secret that there is a level of discontent between public and private GHSA schools, and toward
