My staff searched the minutes for any supplements for these officials and none could be found. Fasting is much different from just refraining yourself from some of your favorite foods. It is a spiritual principle that can yield some great benefits to believers. Fasting should be something that we choose to do for the biblical reasons in order to see biblical results. Of course others fast for other than biblical reasons, yet these are not the reasons that Christ has given to his followers. In Isaiah 58:6-11, the bible "Is not this the fast that I savs. have chosen? to loose the bands of wickedness, to undo the heavy burdens, and to let the oppressed go free, and that ye break every yoke? Is it not to deal thy bread to the hungry, and that thou bring the poor that are cast out to thy house? when thou seest the naked, that thou cover him; and that thou hide not thyself from thine own flesh? 
