"Law enforcement authorities from Georgia and North Carolina had responded numerous times on tips of Carter's presence at Tiger's home. Authorities had spoken to Tiger on multiple occasions and advised him of Carter's fugitive status."

Tiger was given a \$5,000 unsecured bond and will appear in court on May 6 regarding his

According to a GBI arrest warrant, Carter allegedly shot Henderson around 7 p.m. on Sept. 8, 2018, at or near a home located at 11 Lindsay Lane, which has a Young Harris mailing address but is actually in Union County.

Per state law, the crime of aggravated assault occurs when a person uses a deadly weapon or any object "offensively against a person" in such a way that "is likely to or actually does result in serious bodily injury." Aggravated assault carries with it a prison sentence of up to 20 years.

As previously reported, deputies with the Towns County Sheriff's Office responded to Chatuge Regional Hospital in Hiawassee the evening of Sept. 8, 2018, in reference to a male subject with a gunshot wound

The subject was identified as Henderson, who survived the shooting but had to be airlifted to a nearby trauma center.

After allegedly dropping a wounded Henderson off at Chatuge Regional, Carter is said to have left the scene in his Chevrolet Tahoe. The truck was discovered abandoned later that night in the parking lot of the Marathon gas station on Georgia 75 North in Hiawassee.

Detectives determined that Carter left the Marathon in her own red Ford pickup, which was located the next day at Tiger's residence in Clay County, North Carolina. Within hours of

the shooting, the Towns County Sheriff's Office had filed warrants on Carter for aggravated assault and criminal attempt to commit murder.

The Sheriff's Office also requested GBI assistance at the time, after which the GBI took over as the lead investigating

Further investigation revealed that the crime most likely occurred in Union County, and the GBI, after receiving assistance from the is completed, there would likely Union County Sheriff's Office, took out an aggravated assault in July in the appropriate warrant for Carter in Union county.' County on Sept. 11, 2018.

Subsequent to the GBI taking out an arrest warrant in Union County, Towns County Sheriff's Investigator Aaron Deyton requested that the charges in Towns County be dismissed.

Ultimately, what charges and where to bring them will be up to Enotah Judicial Circuit District Attorney Jeff Langley following completion of the investigation.

There is still investigative work taking place to verify the exact location,' said Langley previously. "It is believed that a shot was fired from within a motor vehicle, and there was some question as to the location at that time being in either Towns or Union

County.

"The law requires that charges be brought and, if necessary, a trial take place in the county where the crime occurred. If after due diligence it cannot be clearly determined whether the vehicle was in Towns or Union when the crime occurred, then Georgia law would allow it to be tried in either county.

removed the Battle Flag from the monument.

Compatriot Scott Ledford gave an introduction to the ceremony by explaining some of the origins of the occasion and the importance of decorating the monument and the graves with flowers and remembering those who fought and died during the war. "Back in the day, as

veterans were prone to do after their war, peacetime breaks out and shots stop being fired, and every year they have reunions," said Ledford. "They get together like old soldiers do and they tell stories, and every now and then, they put monuments up.

'After a while, they start looking around and keep hearing so and so just died or they have poor health, and as they started noticing this around the 1890s, they sort of realized that they need somebody to pass the torch, so that's how the Sons of Confederate Veterans got started."

Added Ledford, "This camp last year completed a four-year project for that cemetery up there, which was dilapidated, run down, and covered with weeds. And between coordinating with the state and national levels of the

Berlin also spoke on the importance of preserving monuments and enforcing the laws protecting those monuments, to help keep the memorials for future generations to have and celebrate as they The Sons of Confederate

Veterans make it a point that they are not influenced by politics, but they do want to keep preserving their history and celebrating their ancestors who fought in the Civil War, and they want to continue with their tradition of supporting that

Following the speech by Berlin, the ceremony closed with a benediction by Chaplain Russell Shreeve.

After the ceremony, the group made their way to the Old Blairsville Cemetery to honor the Confederate dead buried there and to continue their memorial service.

Confederate Memorial Day is April 26 every year, though the local observance usually takes place on the nearest Saturday.

The state used to observe the day as a holiday, and though the date remains on the holiday calendar, it reads simply "State
