"At the beginning of the week, all the girls turned in the bills they wrote," said Swanson. "Then, at the House (of Representatives), we either passed them or didn't pass them, and we got into groups. You get to see what you don't see as a citizen when you're not in it."

Floyd, who also attended the Governor's Honors Program over the summer in the area of Social Studies, said the experience was one he will carry with him moving forward.

Swanson echoed Floyd's sentiment, adding that her biggest takeaway was that, in a representative democracy, "every vote counts, because we had very close calls with things that one person made a difference in."

Both Floyd and Swanson

said that they will be promoting the benefits of Boys and Girls State with their fellow students, especially their junior year schoolmates.
