The Center turned to social media last week to request aid for the victims of Hurricane Harvey in south

And the philanthropic spirit of Union County responded. Overwhelmingly.

On Wednesday, the Center posted on Facebook that they were accepting boxes of diapers to ship to Texas, and word immediately spread like wildfire

"I just posted it yesterday (Wednesday, Aug. 30), and I believe it's the highest performing post that we've ever made on Facebook,' Addie Jarrett said that next Thursday afternoon. "People have shared it like crazy and the response has been amazing."

The Houston metropolitan area has been ravaged by Hurricane Harvey's storm surge since the storm came ashore last month. Meanwhile, the Center has experienced a flood of donations since its post went viral late last week, and according to Jarrett, they're having a difficult time keeping up with the incoming supply of diapers.

"We can't keep enough boxes to put them in," she said. "I went to Walmart to get more boxes and as soon as I got back, more diapers were coming in so I had to go back and get more boxes.'

The Center will continue accepting donations into this week. Gooch Trucking will transport the diapers put together to go to Texas. They expect to have the boxes on the truck headed west this week.

"It won't just be diapers on the truck," Jarrett said. "A lot of different organizations are doing different drives. We've also packed some other things like baby blankets, hygiene kits, formula, food, bottles, and that kind of stuff.

"My sister was in Houston and was evacuated," Jarrett added. "She told me that a lot of the shelters need

They are closed on Mondays, Fridays and weekends, however, so anyone wishing to donate diapers should plan on doing so no later than Thursday between the hours of 9 a.m. and 4 p.m.

The Center is always available to help the people of this community with diapers, baby food, clothes, baby furniture, and more. They are located on Jones Street behind the old Standard Telephone Company building on Hunt-Martin Street.
