Ledford named System Teacher of the Year at Towns County Schools By Mark Smith Cornett at the high school and school.

Lisa Ledford of Towns County Elementary School has been named System Teacher of the Year for the 2018-2019 school year.

Superintendent Dr. Darren Berrong made the announcement at the Oct. 8 meeting of the Towns County Board of Education.

Ledford qualified as System Teacher of the Year after being named the 2018-2019 Teacher of the Year for Towns County Elementary.

Also announced in the Oct. 8 meeting were 2018-2019 Teachers of the Year John Kerry Rogers at the middle school.

"I am a believer in lifelong learning," said Ledford when reached for comment after the meeting. "I also believe that everyone has special gifts and of the Year. Ledford is now in talents and can succeed in some way.

"We all need to feel successful. It is my goal as an educator to be a facilitator for that learning with my students.'

Berrong explained that, when it came down to choosing a System Teacher of the Year, the teachers were evaluated by an outside, independent panel.

Considering the news regarding the modernization reimbursement, Berrong recommended that the board approve a resolution to move forward on a tax anticipation note with United Community Bank in the amount of \$1 million.

The money would be used until the reimbursement money could come in, at which point the board office would "pay that back immediately," said

Jury trial set in federal case against Gowder brothers, Heaton

GAINESVILLE-A trial date has been set in the federal prescription drug case against former hospital CEO Mike Gowder, Dr. David Gowder and Dr. James Heaton, according to court documents filed Oct. 10.

The jury trial will take place on Feb. 11, 2019, at 9:30 a.m. in Courtroom 303 of the U.S. Courthouse in Gainesville, before U.S. District Judge Richard W. Story of the Northern District of Georgia.

U.S. Magistrate Judge J. Clay Fuller of the Northern District of Georgia had previously certified the case as ready for trial on Aug. 28,

according to court documents. All three men pleaded not guilty to federal charges on April 9, after a federal grand jury handed up a 212-count indictment listing the Gowder brothers and Dr. Heaton as defendants on April 4.

Each defendant is presumed innocent of the charges, according to the U.S. District Attorney's Office, "and it will be the government's burden to prove each defendant's guilt beyond a allegedly abused their positions reasonable doubt at trial."

The men were indicted as part of Operation SCOPE, allegedly for "illegally prescribing and obtaining thousands of doses of prescription pain medications outside the usual course of

professional medical practice and for no legitimate medical purpose," according to an April 6 news release from the U.S. Attorney's Office in Atlanta.

At the time of their alleged crimes, Mike Gowder was the CEO of Union General Hospital, Dr. David Gowder was the emergency room director at Union General Hospital, and Dr. Heaton ran a family practice clinic in Blairsville.
