## BRMEMC to host Town Hall meetings in Clay, Union counties

Former Blue Ridge Mountain EMC Board President Terry Board's company, Taylor & Taylor Construction, Inc., no longer exists.

Conducting a business search on the Georgia Secretary of State's website shows that Taylor & Taylor Construction, Inc. dissolved on Dec. 31, 2015.

According to the most recent public financial records made available by the Blue Ridge Mountain EMC, dated to Dec. 9, 2014, Taylor & Taylor Construction, Inc. owed \$37,343 toward the debt of \$47,643.53 awarded in May of 2014 to the Blue Ridge Mountain EMC following a civil suit the EMC brought against Taylor & Taylor Construction, Inc.

The current balance of the

Taylor & Taylor Construction, Inc. debt is not public record, according to BRMEMC Interim General Counsel Larry Ford, who stated that it was against general EMC policy to discuss individual member accounts.

Furthermore, since Taylor & Taylor Construction, Inc. no longer exists as a legal entity, the fate of the debt has been thrown into question.

"Based on that new information, I will have to research what legal effect the dissolution has on the situation under discussion, report to the board my findings, and then the board will consider what should be done in the best interest of the EMC and members," said Ford in an email to the North Georgia News.

On Tuesday, Jan. 12, members of the news media were invited to the BRMEMC boardroom to ask direct questions of the board

of directors, just before the start of the first board meeting of the New Year.

This latest move toward transparency comes

after BRMEMC Board Vice President Mickey Cummings announced two upcoming Town Hall Meetings in which the membership will be able

to ask questions directly of the board.

"I passed it was last month, we passed a new policy that requires Town

Hall Meetings to be held periodically throughout the year," said Cummings in the Q&A. "And the first two of

Those using the tennis courts and pickleball courts must provide their own tennis rackets, pickleball paddles and balls and wear proper shoes that don't mark the playing surface and abide by the rules posted at the courts.

## Board of Education SPLOST referendum

The Towns County Board of Education is hoping to embark on a huge maintenance project, and they hope the community will understand on May 24.

Finding that the schools are in great need of system-wide maintenance, the board recently voted to take action.

In the January BOE work session, the five-member board voted to approve a SPLOST referendum to be sent to the Towns County Board of Elections to be included on the May 24th General Primary Election ballot.

This referendum will allow residents of Towns County to decide whether or not to institute another 1 cent of sales tax per dollar countywide,

increasing the sales tax to 8 cents on the dollar as early as July of this summer.

The biggest and most pressing issue currently facing the school system is a badly damaged roof of the joined middle and high schools.

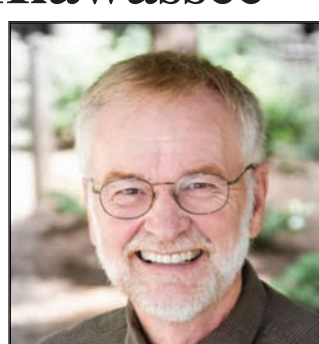
For Hiwassee City Councilman Stephen Smith, a new year means changes.

## BOE approves facilities plan

The Towns County Board of Education met for the first time this year on Monday, Jan. 11, to discuss pressing business.

Towns County Superintendent Dr. Darren Berrong had some good news for teachers, specifically those that have several years of experience.

"We passed the personal leave policy for the teachers. We had to lay that on the table for a month, so that policy did pass," said Dr. Berrong, referring to extended personal leave days.

Next, the Board approved the current Five Year Facilities Plan, which details potential problems with infrastructure and recommends fixes.

"The Board has to approve for the Georgia Department of Education to work with us on our Five Year Facilities Plan. Our Five Year Facilities plan is coming to an end and that's another reason why we have all the projects that we have. Because we're doing that Five Year Facility Plan, we can see what are the things coming up that we need to be replacing," he said.

He explained that the plan explains what maintenance the school should look into in the near future.

"The plan working with the DOE sits down and kind of says, 'Okay, here are your old all the things are in your building, and what do you need to be replacing or looking at fixing?'"
