over the Southeastern United States to the mountains that we have here, and the natural beauty we have here with Lake Chatuge and Hiawassee and Young Harris.

"I'm more encouraged about some of the things that we did that may not seem to have worked. We spent an entire year working with the Fanning Institute out of the University of Georgia in a collaborative thing with the Georgia Chamber of Commerce, where we studied our county. We studied where our people are, who they are, where they came from, and what kind of things they want," he said.

To Dehler, it isn't just the businesses in Towns Čounty that make him love the area – it's also the people.

"We came to realize pretty early on that we have a very unique combination of people in this county. A lot of people have come here from other places. They've come here for odd and different reasons, and some are unique to themselves. And the thing

that's exciting to me about the leadership of the next couple of years is the youth. I'm not a young guy. John Allen is," he said.

John Allen spoke on his position at the chamber.

"I feel like we have a real good group of folks that represent the community at large. We're trying to hit all the different sectors. We've really refocused the board," said Allen.

"All the reasons why I joined the chamber is because of a whole other set of alternative benefits. I don't sell any houses out of doing this. I meet good people. And it's really not a self-serving board. That's the cool takeaway about the chamber. It's about the greater good, and we want the best for this area. It's nonpartisan, it's an elected board, and I love the transparency. It's a pretty awesome organization."

issue is legally complicated. "Generally speaking,

the rule is, a city can't call a referendum in a dry county on package stores for certain," said Stancil. "There's an issue about 'by the drink.' But with all that said, we'll take a look on all that and report back to the council next time (in March), because we may just do the easy thing and do what Young Harris did. The only difference is it'll be a closer vote, because conservative Hiawassee versus a college town, there's a lot of difference. I still think it'll probably pass, but it'll be a little controversial."

The city has previously attempted to bring alcoholrelated businesses within city limits, only with limited results.

"We talked with one distillery a couple years back. Grandaddy Mimm's, trying to get him in the city, but there's a whole different set of laws that apply to the distilleries. There's a different set of laws that are being amended all the

time," he said. Alcohol laws in Georgia tend to be complex and multifaceted, influenced from several different directions.

"The Georgia General Assembly by special statute gave cities the ability to hold a referendum on Sunday sales.³ said Stancil. "It was authorized by the General Assembly for cities to do the Sunday sales. The language that is required to be used for the referendum under state law includes language regarding liquor by the drink.

"But their thoughts were it only applies where liquor by the dink has already been approved. Some cities have argued because they've put that in there, they've authorized cities to approve liquor by the drink, and that hasn't been sorted out through the courts.'

Going forward, the city will have to wade through all the required legal language and processes.

"When we put the question out, it's going to include the statutory required language, same thing as Young Harris. As to the effect, if it gets approved, that's going to be a different question, he said.

Stancil was in agreement with Ordiales, in that Sunday sales could be beneficial to the city.

Toxic Exposure Research Legislation is needed for Veterans of every generation

(Wash., D.C.) - On February 10, Department of Veterans Affairs Secretary Bob Mc-Donald told Members of the House Committee on Veterans Affairs that no legislation on Agent Orange or Toxic exposures is needed. This statement by the DVA Secretary is in line with testimony, delivered before Congress on three occasions in the last eight months, in which the VA claims no research legislation is needed as other Agencies of the Federal Government are doing all of the research studies needed.

John Rowan, National President of Vietnam Veterans of America (VVA) responded, "With all due respect to the Secretary, he could not be more wrong. Furthermore, we have yet to receive a list of these research studies referenced in VA testimony which purportedly pertain to veterans and their progeny."

The events in the past week highlight the shameless wall of ignorance erected by the VA bureaucrats. Case in point is the Secretary's recent policy regarding the Blue Water Navy veterans of Vietnam. The policy states that a 'bright line' can be drawn across the mouth of a flowing river, with those on the inland side of that imaginary line being 'exposed,' and those two feet away, on the harbor side of the line, 'not exposed,""

said Rowan. "Those 'exposed' are eligible for presumptive service connection for certain conditions, and therefore medical care and compensation, while those who served two feet away are not. We are leaving our Navy veterans out in the cold, and sadly, many of them have died and their widows have been abandoned."

"Also on Wednesday, the Institute of Medicine (IOM) released a report on Gulf War illness, which I find troubling,' noted Rowan. "Psychiatrists/ psychologists comprised half of a panel charged with evaluating medical conditions, most probably caused by exposure to toxic chemicals. It comes as no surprise that this recent report ignores the many toxins to which Gulf War veterans were exposed and reverts to the canard that unless 'causality' can be proved by a specific toxin, there can be no forward movement. One would hope the VA and DOD would be looking for an 'association' of exposure to one or more toxic substances and the presence of adverse medical conditions, rather than placing an emphasis on the 'mind-body contin-

is able to do what is needed without legislation," said Rowan. "However, the VA has made its case repeatedly that, in the absence of legisla-



tion, there will be no justice accorded veterans with Toxic Wounds, nor for their innocent children and grandchildren. America's veterans of every generation DO need early passage of S. 901 and H.R. 1769, the Toxic Exposures Research Act, and vigorous oversight after enactment to ensure that VA actually does what is mandated in law; we need immediate passage of the Blue Water Navy Vietnam Veterans Act of 2015, H.R. 969 and S.681; and we need to push for the extension and expansion of the Agent Orange Act of 1991, to include veterans of recent and future wars, so that a system is in place to systematically review battlefield exposures, and they won't need to refight the battles we have."


