Every statement that I have received in all the years I've had an account with BRMEMC have carried the statement "Service may be discontinued without notice if customer bill is unpaid--10 days after due date" There is normally, probably, an automatic disconnect after the allotted time has gone by, but was this person selected for preferential treatment for two years because he was the Board Of Directors Chairman of our Blue Ridge Mountain

Perhaps we should investigate the president of our BRMEMC--and the person in charge of seeing that each member's bills are currently being paid--who else is allowed to keep service indefinitely while not paying their bill?

We might find all kinds of shady practices. I think our city, county, and/or State Attorney General needs to make a thorough investigation of this power company!

I have a question about the announced total amount to be paid by Mr. Taylor. Late payment charges are due starting the day after the payment has not been paid. Has their bill been charged with interest added on month after month or has Mr. Taylor been given a lower amount due than us lesser important members? I for one, insist that he pay every last penny of every month's cumulative penalties. It seems to me the total published amount should be higher. Looking at my current statement of the penalty amount should I not pay when due, it shows a fairly high rate of interest charged (I don't ever have to pay a late fee because I am an honest consumer that always pays her bills on time), I also believe the person or persons who allowed this debacle, should be fired immediately without any benefits allowed (such as possible retirement), This is a despicable scandal.

forest today, the results of over forty years of periodic infestation by the Southern Pine Beetle can still be seen. I know of several patches of woods where you cannot walk ten yards without stepping over the slowly decomposing trunk of a

Beetle is a naturally occurring species found in Georgia. The large stands of monoculture pine which enabled the beetle to multiply far beyond its natural restraints, costing landowners hundreds of millions of dollars, were not naturally Over a thousand spe-

cies of bananas can be found around the world. However, 99% of bananas grown commercially are the Cavendish strain, which is now suffering from a soil-borne fungus that threatens a staple that we take for granted as being inexpensive and universally available. Monoculture in the

natural world is an unstable condition.

In the world of economics, it can be argued that "monoculture" is also undesirable. Consider the hundreds of thousands of small to medium sized locally owned businesses that have been replaced by Walmarts full of goods manufactured in China. Witness the hollowing out of communities that results when big box stores like Home Depot and Lowe's move to the outskirts of town and draw business away from the core.

Let's look at the economic issue in another way. The lesson of economic "monoculture" should still be fresh in our memories, having witnessed the devastation caused when people stopped building houses in our local economy that was so dependent on home

In the forest, monoculture invites disease and infestation, invasive and non-native species. In town, economic monoculture can lead to entrepreneurs and business owners becoming low paid employees of invasive corporate chains, or worse, unemployed.

"Diversity" is a word which has become a politi-

But if we do not shop locally whenever possible, we are hollowing out the soul of our small towns and destroying much of what attracted us to them in the first place.
