Banners and signs will be put up ahead of time, the road down to the fenced area will be graveled, and one side of the fence will be rolled back so vendors can drive in and park. Big wooden cable spools will be used as tables. Friday night was a life altering and memorable event for the 58 Towns County High School Seniors that walked across the aisle of the Bill P. Kendall Gymnasium, waved to family and friends, took their seats, and waited anxiously for the graduation ceremony to begin.

The program opened with the traditional Pledge of Allegiance, followed by the National Anthem which was performed by Courtney Farmer.

Hiawassee man drowns in Nottely

Blairsville - The search for Jamie Ian Worley came to a close on Monday when divers with the Georgia State Patrol Dive Team recovered the 18-year-old's body from the chilly waters of Lake Nottely in Union County.

At 11:15 a.m., two

divers from the Georgia State Patrol Dive Team discovered the body of the 18-year-old boy that lived and worked in Hiawassee. Worley was a night shift stocker at Ingles of Hiawassee.

Union County Sheriff Scott Stephens said that

Union County Deputy Coroner Benny Brookshire is in charge of the investigation to determine cause of death. The cause of death is undetermined at this point, Sheriff Stephens said.

"We can't speculate on causes," he said. "We'll just have to wait until the medical results come back to give us a final say on what happened to this young man."

Worley's mother, Shannon Ashe, said that she'll remember a boy who loved to play sports. His first year wrestling, his mother said he

finished the season 15-0.

"It's extremely hard to deal with all of this now," Shannon Ashe said. "I haven't slept in two nights."

"As a child, and until the day he died, Jamie was a very sweet and loving child," Shannon Ashe said. "He enjoyed sports, he played baseball, he played football, and he wrestled and ran Cross Country. He was a little fellow, but he never let that bother him. He loved to fish, he loved his sister

Gunter, George to serve Enotah Bench

Georgia Gov. Nathan Deal has made a final decision regarding who will preside over the two vacant Enotah Judicial Circuit judgeships.

Gov. Deal selected Blairsville's Stan Gunter and Dahlonega's Raymond George to fill the vacancies created when Senior Enotah Circuit Judge David Barrett retired, and Enotah Circuit Judge Lynn Alderman resigned in March, according to the Governor's Office.

The two men are scheduled to be sworn in by Gov. Deal on June 7th, according to the Governor's Office. They will assume their duties immediately after their swearing-in ceremony, according to the Governor's Office.

Gunter, whose father once presided over the Mountains bench that included Union and Towns counties, and George, were selected from a short list of

five candidates that also included Hiawassee attorney Rick Stancil, White County attorney Stan Lawson, and White County Magistrate Judge Joy Parks.

Gunter and George will join Enotah Circuit Se-

Qualifying ends; Kimsey won't seek return to BOE

Rogers, Dye unopposed; Kendall, Clinton have opposition

Qualifying for the 2012 primary and general election has concluded with a surprise or two.

Post 4 Board of Education member Larry Kimsey did not qualify for reelection. There are two hats in the Post 4 non-partisan race, Rodney Thomas and former BOE member Bob Gibby.

In Post 5, Incumbent Donna Hedden faces two challengers, Laura Diehl and Penny Ledford. Both BOE races are non-partisan.

Two county officials were unopposed following qualifying. Incumbent County Clerk of Courts, Cecil Dye is running with out opposition as is Probate Judge David Rogers.

Sole Commissioner Bill Kendall, the incumbent, qualified for reelection on the Democratic ticket. He'll face opposition in November as Steven Gerdes has qualified on the Republican ticket.

Incumbent Towns County Sheriff Chris Clinton qualified on the Republican ticket for reelection. He'll face Darren Osborn, who

qualified as a Democratic candidate for sheriff.

Incumbent Tax Commissioner Bruce Rogers qualified for reelection on the Democratic ticket and will face Republican opposition in Bill Kuykendall in November.

Incumbent County Coroner Ricky Mathis qualified for reelection on the Democratic ticket and will face November opposition when he faces Republican Tashina Hall Eller.

In the Georgia General Assembly, Republican State Sen. John Wilkinson faces no opposition in the upcoming Primary or the November general election.

In the State House, Republican State Rep. Stephen Allison faces opposition in November when he will face Rabun County Democrat Jana Hill for the District 8 House seat.

In State House District 7, Georgia House Speaker David Ralston, of Blue
