Upon closer look, Minor's report uses phrases such as "reasonably confident of the following conclusions.'

So, what we're learning here is that basically, Steven Mi-

nor's \$30,000 internal report was a \$30,000 internal opinion. Case in point, when the newspapers reported that General

Manager Matthew Akins made false reports to the Internal Revenue Service on Nonprofit Form 990 based on revelations in the Minor Report, EMC officials told a crowd at Mary's Southern Grill in Young Harris on Friday that this was Steven Minor's opinion. So, it certainly looks like it's Minor's opinion that no sit-

ting member of the Board of Directors knew anything about a five-digit debt owed by former BRMEMC Board President Terry Taylor's commercial stone crushing operation. According to the Cherokee Scout in Murphy, NC, the report

on the BRMEMC website shows the board knew nothing about

the debt. We've actually reported that as well. However, for the report prepared by Steven Minor for BRMEMC to indicate that former and now deceased BRMEMC Board Member Jack Lance Sr. knew about the debt as early as 2009, well, where did you get that information? Possibly from a

Unless Minor has a Quija Board, that's the only place Minor could have gathered the information.

Actually, Minor says he got the information from current Board Member Bill Prather. Mr. Prather reported to Minor that in 2009 Lance Sr. shared with him information that a director had not paid his EMC bill in several months. Mr. Prather did not believe that Jack Lance Sr. specified the director's name, and Mr. Prather did not inquire further about it.

Well, we can't ask Jack Lance Sr. to verify this can we? And it is amazing that the only board member who knew about Terry Taylor's indebtedness is now deceased and has taken this information with him to the Pearly Gates.

However, it certainly looks like a fact in the Minor Report. although, there's no way Minor could have verified this information - unless he had a Quija Board. The Minor Report also throws former EMC General Man-

ager Joe Satterfield under the bus. Of course, now we know that Mr. Satterfield's involvement - where he was alleged to have created a defacto policy of allowing Taylor to skate on his bills - was As we head into the Sept. 13 Annual Meeting at Anderson

Music Hall, we've learned that the BRMEMC Board of Directors approved the use of \$30,000 in membership money to create an educated guess about how Taylor and Taylor Construction was able to generate a debt of more than \$48,000 in unpaid utility We've also learned that Taylor and Taylor Construction did

pay their bills - at least every two or three years. They got away with that because the threat of disconnection was not there, according to the Minor Report. The Minor Report also says that EMC Legal Counsel Lawrence Sorgen knew about the debt in May or June 2013 and was

told by GM Akins. If that's a fact, why didn't the board find out until March 2014? To his credit, Sorgen demanded that Taylor pay his debt im-

Nevertheless, we arrive again at fact or opinion?

According to the Minor Report, Sorgen had no contractual duty to disclose the news to BRMEMC's board of directors.

The future path of BRMEMC is now in the hands of its

membership - 43,000 strong. Do we fix the sputtering carburetor or just wait until it finally breaks down? The choice is ours as owners of the cooperative. If you're

tired of the current individuals who claim amnesia when it comes to knowing about something they should have known about, then, it's time for a change.
