The \$62,354 Glitch

Blue Ridge Mountain EMC Director Jerry Nichols needs to get more in tune with the Cooperative's customers.

Speaking before the Mountain Movers and Shakers in Young Harris recently, he told the group that the EMC didn't have "any accounts, anywhere on Blue Ridge Mountain EMC that uses \$60,000 worth of power a month."

Well, we had to do a little digging, but, we found a couple of users that do use \$60,000 a month or more, and they are BRMEMC customers.

Following an open records request by the North Georgia News and Towns County Herald, the newspapers learned that Union General Hospital pays more than \$100,000 a month, depending on the weather, for electricity.

Also, the Union County School System averages \$50,000 to \$80,000 a month based on how Mother Nature is cooperating.

We're certain that both the hospital and the school system would be happy for the EMC to declare their monthly bills as meter glitches, much like the \$62,354 correction (glitch) that was made to Taylor and Taylor Construction's bill in July.

The only problem that Mr. Nichols seems to have is that someone made sure we had a copy of Taylor and Taylor Construction's June 10 bill which showed a balance of \$107,998.43.

If we were in Mr. Nichols' shoes, we would be more concerned with the fact that the former president of BRMEMC's board of directors had indeed received a perk of not being on a cutoff list with his commercial operation's ability to continue to use electricity not threatened.

And, as we have learned from the \$30,000 opinion put out by EMC Attorney Steven Minor, Mr. Taylor also was \$4,200 or so in arrears on his residential power bill.

Those are things the EMC Board of Directors need to be concerned with, not whether someone finally spilled the beans.

There will be a final tally of votes for the three seats currently up for grabs on the EMC Board of Directors. The only question we have is who will be counting the votes. And we're also concerned that EMC employees are being directed to vote for the incumbents on the board. We've seen documentation that this has happened.

Until Saturday, all we can do is cross our fingers and hope for a legitimate election. The membership demands it.

One thing that has fascinated me about our community for years is the consistent ill will that many of us seem to harbor for the power company. While we depend on it for almost everything that keeps us alive, safe and entertained, we criticize its policies; we loathe the substations and power poles that keep us from freezing in the winter. We resent the expensive new building and the rates that always seem to be going up. We complain in online forums, emboldened by anonymity, in vile and vitriolic ways. We bad mouth the company at the water cooler, in the checkout line and even inside the church house.

This is not just a recent phenomenon. Ask anyone who has lived here for a long time and they will tell you that this resentment stretches back decades, surviving a succession of Board members and managers.

Any number of municipal entities or large corporations can become a target of our ire. In our area, however, the local government and the power company are the only big targets available.

The Board of Directors of BRMEMC, as members of this community, were in a position to recognize the weight of public opinion when they approved the building of an expensive new facility in an area with a depressed economy where businesses were closing left and right. This, on the heels of a controversial placement of gigantic transmission lines through the heart of our most populated area and unfortunately, just before another rate increase. It should come as no surprise to the Board that public resentment, having reached a crescendo in recent years, would sink its teeth into any action that could be seen as a violation of public trust.

Clearly, such a violation occurred when the past president of the Board remained in office after the inability to pay his power bills caused him to no longer be a member in good standing.

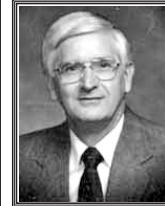
As it has been reported in this newspaper and on the BRMEMC website, steps have been taken to correct the mistake. Mr. Taylor has resigned from the Board and new fiscal oversight is being put into place to make sure that this type of thing does not happen again.

The reputation of the power company has suffered in the wake of these events, and in my opinion, much of the venom directed at this organization as if it were a faceless, non-human entity is unjustified. BRMEMC is not faceless. Indeed, it is 200 of our neighbors, friends and family members. The hard working, underpaid and patient voices on the phone who take our calls when we are cranky, rude or misinformed - are not responsible for the company's woes. The crews arriving at work before daylight to begin another day of dodging yellow jackets and hornets in the heat while maintaining our rights of way; the heroes who put themselves into harm's way, day or night, 365 days of year in every kind of weather, driving on icy roads and climbing poles in thunderstorms to keep our lights on, our air conditioners and heat pumps running - are not responsible for BRMEMC's problems. These people, not the Board of Directors, are the real "power company," and we should remember that when we air our grievances.

Time and time again, BRMEMC has proven to be a well-managed utility with many highly qualified and caring professionals at all levels.

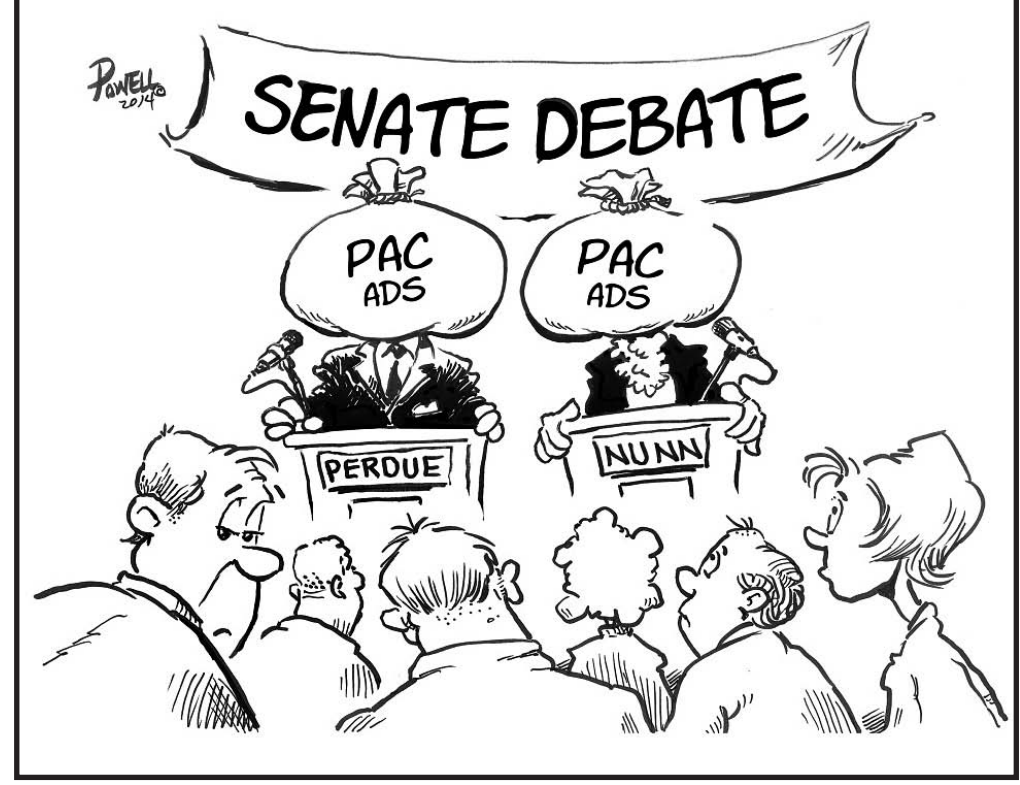
Too often it can be too easy to forget. Thank you to all the professionals at BRMEMC. What you do every day is greatly appreciated.
