MRLS continues search for new library director

"One of the issues that I raise is that the way the state does the budget, the difference between my salary and the new Blairsville - The top person coming in goes back to candidate to fill the position as the state – we don't get to keep any of it," said Howell. "So, if your new person starts in December, then my payout for my unused annual leave will have to come out of local money because the state will not pay a person to fill a position and the unused leave of a person who's leaving, even though I earned every bit of that leave as a state-paid person.' Howell, who is "unwilling to put the board in the position of having to furlough locally paid staff in order to pay out" her annual leave, presented a compromise to the board that would allow her to retain 30 days of her unpaid leave and keep things running at the same time. Since her retirement is set for Dec. 1, she is not legally able to work for the month of December. Should a new director be selected before the New Year, she proposed that this person start on Jan. 1, which would leave the library system without a director for December. 'My recommendation is that Wilma Ash, who has been with the library system over 40 years – she actually retired with 40 years and she still works part-time for us when we need her as a fill-in person," said Howell. "But she used to be bookkeeper for the system. I would recommend that we allow Wilma to do the review of the vendor checks to reconcile the invoices and everything, and approve the payouts." Ash is currently on payroll as a part-time accounting assistant, and would be able to handle the financial matters of the library system for December, such as payroll and fiscal responsibilities. 'We're already closed most of the last week or so on that month, and typically our library usage is down during that month because so many

There's no place like home for Alejandro

Given a list of his accomplishments, one might not guess that Towns County High School senior Alejandro Lemus-Gomez has only been in town for about a year and a half.

director of the Mountain Regional Library System declined the position after considering the offer over the weekend.

The candidate was selected in a vote on Thursday, Oct. 30, when the MRLS Board of Trustees held a called meeting at the Union County Public Library to discuss the next director.

Current Director Donna Howell is set to retire at the end of December, following a onemonth paid leave starting Dec. 1, with a new director hopefully taking over Jan. 1.

The director search committee consists of Teresa Moore, Chair of the MRLS Board of Trustees; Dr. Jounida Bradley, Chair of the Towns County Library Board; Ed Reed, Chair of the Union County Library Board; and Ron Bolin, Chair of the Fannin County Library Board.

Howell served as a facilitator to the committee, but had no vote in the process.

"The committee also asked for input from all the library staff in all the branches," said Howell.

And while the current situation is certainly a setback, the board still has options.

"The committee will have to get together again to decide whether to offer to another of the current candidates or re-advertise the position and try again," said Howell.

The MRLS comprises the Mountain Regional Library in Young Harris, and public libraries in Towns County, Union County, and Fannin County. These libraries have benefited from Howell's leadership for 25 years, as she has served 15 years as assistant director, followed by the last 10 years as director.

Howell has worked hard over the years amid shrinking staff and state-mandated furlough days, and as such has given up more than 200 days of authorized leave time to keep things running smoothly. Even now, as she retires, she can only be paid out a maximum annual leave of 30 days.
