# Recount results: Eller wins Towns Coroner's Race

The recount for the offices of Tax Commissioner and Coroner took place on Thursday afternoon, Nov. 15th, with no change in numbers.

Tashina Eller is Towns County's new coroner after she officially defeated Incumbent Rickey Mathis by four votes.

The recount included early voting, precinct voting, absentee ballots, and provisional ballots. The numbers were recertified and made official.

The results have once again been sent to the Secretary of State.

Eller remains the clear winner for the office of Coroner by four votes.

In the race for Tax Commissioner, Incumbent Bruce Rogers held his lead of 50 votes and will remain in office as Tax Commissioner for another four years.

Regarding whether or not he will contest the results of the race for Tax Commissioner,

challenger Bill Kuykendall said, "I haven't made any decisions right now."

Rogers was humbled by his return to office.

"I am humbled by the voters' confidence in me and I will continue to serve as your Tax Commissioner to the best of my ability," Rogers said. "I want to thank my family for their support, the voters who supported me, the folks who campaigned for me, and to anyone who played a part in my reelection. I thank you from the bottom of my heart."

Republicans and Democrats alike turned out in large numbers to learn the outcome of the contested races as Mathis and Eller, and Kuykendall, the Republican candidate for the office of Tax Commissioner, waited for a recount.

Prior to the recount, Mathis had stated that he would not contest the outcome of the recount.

On Monday, Mathis issued a statement.

"I would like to thank the many individuals who supported me in my recent race

for the Office of Towns County Coroner," Mathis said. "I sincerely appreciate all voters who turned out in large numbers to exercise their constitutional right to vote.

"I would also like to take the opportunity to thank the many individuals who assisted me during my many years as coroner," he said. "Without your support, a difficult job would have been more difficult.

As many are aware, on Election Day, I received 16 more votes than my opponent," he said. "However, an unusually large number of Provisional Ballots were cast. Based on the limited number of Provisional Ballots counted by the Election Office, Ms. Eller was named the winner by four votes.

"Despite my repeated requests that the Election Board count all legal votes, the Election Office chose otherwise," Mathis said. "In considering all my options, after thoughtful prayer and conversations with family and friends, I have decided that a legal challenge

would be costly and not in the best interest of Towns County.

"Therefore, I wish my opponent well as she takes on the challenge of the office," he said.

Eller said the recount confirmed the election night voice of the voters.

"After the calculation of initial votes and the provisional votes, Towns County voters have spoken," she said. "The recount today only confirmed the voice of the voters."

"It is time to move on and get to work as initial training begins in a few weeks and the formal swearing in takes place in January," she said. "I applaud Rickey Mathis for a spirited campaign and I look forward to serving our county as the first female Coroner in the history of Towns County."

"To everyone who has stood by me, voted for me, supported, and prayed for me, thank you," she said. "It is an honor to have you by my side. I have many plans for the future of this office," said an elated Eller. "Thank you all."

Fans weren't going to miss the last opportunity to see "the Possum" bid Hiawassee adieu.


Jones opened with his classic *Why, Baby, Why* and the fans were on their feet and screaming 'we love you George.'

# BOE holds tax hearing

Wednesday, Nov. 15th, was a very busy day at the Towns County Board of Education as they held their Tax Digest meeting to discuss the increased millage rate.

A large number of interested citizens turned out to voice their concerns and to hear the explanation as to why they were going to be paying higher school taxes.

The general consensus from the public was clear. They do not want to pay higher taxes and they are not satisfied with the way the school budget is being handled.

The main concern expressed by those present was that too many teacher cuts had taken place while no administrative positions were being cut.

They also felt that the school board was not doing

all they could do to ensure no additional taxes would be imposed on the citizens of Towns County.

School Superintendent Melissa Williams spoke regarding budget cuts and the millage rate increase saying, "Several factors regarding school funding have created the 'perfect
