Council considers water/sewer rate ordinance

Young Harris - The Young Harris City Council is exploring a proposed 2014 Comprehensive Water & Sewer Rate ordinance.

City Engineer Chris Poje explained to the Council that the rates in the proposed ordinance were devised through a comprehensive assessment of past rates and rates comparable to surrounding areas.

According to Poje, the city of Young Harris has continuously had one of the lowest residential and business water rates, and unfortunately this is causing the city to lose revenue.

Poje explained that in accordance with federal and state agencies, the rates are based on EDUs, or the "Equivalent Dwelling Unit," which is a way to standardize the rates, and it is the fairest way to get an approximate rate among

residential and commercial customers.

Poje explained, "a residential home counts as one EDU because they have one meter." Whereas, an establishment such as Young Harris College would be counted and charged a rate based on approximately 32 EDUs" because of the number of meters on the campus.

According to Poje's estimates, based on EDUs with 2-inch meters, a residential home would pay about \$6.16 per 1,000 gallons, a commercial unit is estimated at \$6.11 per 1,000 gallons, and the college would pay approximately \$5.41 per 1,000 gallons.

However, Jay Stroman, Vice President for Advancement at YHC, local attorney Lawrence Sorgen, and Mark Taylor, Chairman of the Young Harris Board of Ethics, were present at the meeting to ensure that the ordinance is passed in "a legal and ethical manner."

the main issue the college has with the council attempting to adopt the rate ordinance is that they "did not receive a copy of the proposed rates until two weeks ago," and they feel that they haven't had not sufficient time to review and discuss the proposed 2014 rates.

In addition, and support of this issue, Taylor informed the council that "the center piece of ethics is that you follow your charter; the charter is the constitution for the city," and based on what Taylor describe as City Charter section 2.15b, "an ordinance may be introduce by a member of the council; but I have not seen a single council member suggest that this is their ordinance they are suggesting.'

Taylor and Sorgen feel that on a legal basis, the ordinance could not be passed during the December meeting.

In a meeting prior to the city council meeting, Young and the city attorney met with Stroman, and according to Mayor Gibby, she informed Stroman regarding his concerns about the rates for YHC that she "would facilitate any requests or concerns the college has in regards to the pro-

Councilman Dr. John Kelly spoke up during the meeting regarding the need for attorneys to be present, suggesting legal action, if the proposal was voted on during this meeting, and he said, "I remember when things were worked out neighborly instead of legally. We (the City and the Council) love this institution and this institution felt the need to make this a legal stance, I am somewhat ashamed."

As of the close of the meeting, no decisions regarding the rate ordinance were made, except that discussions would continue at a future meeting

According to Stroman, Harris Mayor Andrea Gibby posed rate ordinance.
