#### **IRS Whistleblower**

Bombshell Whistleblower Testimony - As you may know, two IRS whistleblowers pulled back the curtain on the federal investigation into Hunter Biden

and the allegations are damning.

Just two days after the Department of Justice announced Hunter's sweetheart plea deal, Republicans on the House Ways and Means Committee voted to publicly release transcripts of the IRS agents' testimonies. These bombshell transcripts reveal the corrupt contours of the years-long investigation into Hunter Biden.

According to IRS supervisory criminal investigator Gary Shapley and a second unnamed IRS investigator, the DOJ repeatedly stonewalled efforts to probe Hunter's criminal behavior, in-

cluding activity related to tax evasion and foreign business dealings. For example, IRS and FBI agents were blocked from searching Hunter's residence as well as a guest house at Joe Biden's Delaware mansion, where Hunter frequently stayed. Additionally, Shapley claims that U.S. Attorney Lesley Wolf tipped off Hunter's legal team before investigators searched his storage locker in Northern Virginia, allowing ample time to remove evidence from the facility.

In addition to more examples that solidify the preferential treatment Hunter Biden received from the DOJ, the IRS whistleblower testimonies raise serious questions and concerns about Joe Biden's involvement in his son's shady foreign


Talk about a smoking gun!

#### Fire Ants

Watermelon is almost a necessity for the 4th of July in my opinion. Everybody has a favorite way to eat watermelon. Mine is to put it in the fridge to get it nice and cold, cut it up in slices, and put a little salt on each bite as you





eat it. If you don't have a fridge around a cold creek is a good alternative. But, if you accidentally pick a watermelon that's not all the way ripe, it might be a bummer once you cut it open. With the 4th of July coming I thought I would talk about how to select a ripe watermelon. Watermelon requires a lot of heat to be able to grow.

That means that watermelon grown in the mountains won't be ripe in time for the 4th of July. There are smaller varieties that don't take as long to grow. Typically, watermelon take 70-90 days to be ready to harvest. If you are planting your own watermelon it's typically easier to start them from transplants, but you can start your own seeds. Watermelon plants will need 8 feet of space on each side.

If you are picking watermelon off the vine you want to look at the curly tendril that is on the stem closest to where it meets the fruit. When you see that curly tendril dry up and turn brown the watermelon is ripe and ready to harvest.


If you are looking at watermelon that has already been picked there are a couple of tricks that you can use so that you look will a pro and WOW onlookers at the grocery store or market. You can thump a watermelon to gauge its ripeness. A ripe watermelon will have more of hollow thud sound to it. An unripe watermelon will have a higher pitched, less hollow sound to it. It's usually best to thump multiple melons with this approach to really be able to gauge the ripeness. Another approach is the check the ground spot. This is just the spot where the watermelon sat on the ground. If it has a creamy yellow or buttery white color then it is ripe. If the ground spot is plain white then it's not ripe yet.

As watermelon ripen the green color will start to dull. So, if the watermelon still has a sharp green hue, it's probably not ripe. If you are picking a striped watermelon this method is particularly useful. Another tip is to pick up two watermelons of similar size. The heavier one is riper. Be careful using this tip because if it is too heavy, then it's overripe.

A whole watermelon will stay ripe for about 2 weeks if its stored below 60 degrees. At run temperature it will last for

Seedless watermelon is very popular and make up 92% of watermelon sales in the US. Seedless watermelon is not genetically modified, rather it is how they are bred that makes them seedless. Some watermelon is diploid, which means they have 2 sets of chromosomes. Other watermelons are tetraploid. which means they have 4 sets of their chromosomes. When plant breeders cross pollinate a diploid with a tetraploid it creates a watermelon that produces a seed that are triploid. Those triploid seeds are planted to make seedless watermelon. Triploid watermelons are sterile. It's a similar concept breeding a mule, which is a cross between a horse and a donkey. These seedless watermelons might still produce a few seeds, but they won't mature and turn black.

We prefer to buy American made products. They are not always, or often, it seems, easy to find. When we do find them, they are usually more expensive, though not always of a superior quality.

Time and distance factors into your decision to roll into the parking lot of whatever store happens to be nearest without pausing to consider the economic or philosophical implica-This was the case recently when I found myself in one of those big box stores looking for a downspout extension. her to glance up from her computer screen. She answered my query by pointing to a corner of the store a short hike from the A brief search of the area convinced me that my item was not there, so I approached what appeared to be an informal

gathering of several employees and politely waited for one to finish telling her story. I was then directed to the opposite corner of the store in the back of the garden section. I don't mind walking. It's one of the healthiest things we can do, but I had made other commitments for my time, so I

approached the area at a trot. After a quick ten-minute search of the area I found the label for my extension. It was out of It was just as well that the store was out of my item be-

cause the price over that empty space on the shelf was shocking, doubly so considering that I knew my item contained about 30 cents worth of plastic. I left the store mentally reorganizing my repair plans for the afternoon. Sometimes thinking outside the box happens naturally

when we are required to improvise and adapt. Clear of that (big) box I remembered that my brother-in-law had recommended an Asian company which provides free shipping for items direct from the factory.

I went online to discover what was available. I saw the item I needed in my first search. It was identical to the outof-stock item in the big box store, but I could get two of them for the same price, plus an adapter, and mounting hardware as

I paused for a moment to consider what "Buy American' means in the global tapeworm economy. The big box item and the online item were both made in the same factory in Asia. Big American Box probably paid half or less wholesale of the online cost for my 30 cents worth of plastic, before doubling or tripling the price for retail. I could wait for Big Box to restock and help improve their stock price on Wall Street and contribute a few pennies to the economy of a nearby town, or I could retain an extra \$10 to put into my own gas tank. Score

The same logic applies to our grocery shopping. I can help support an American job buying groceries at a North Carolina based grocery chain which charges customers in our area more than their stores in other places. Or I can pay 1/3 to 1/2 less at a locally run German owned grocery, support an American job, contribute to a local tax base and save enough money to pay for my gas and eat out for lunch.

What do you think my choice would be? Das ist ein klarer Fall. That's German for "The answer is obvious," which is their equivalent of "It's a no-brainer."
